***Understanding Sexual Violence: The Judicial Response to Stranger
and Nonstranger Rape and Sexual Assault***
A Model Curriculum for In-Person Judicial Education

A multi-module, interactive, one- or two-day model curriculum that covers victim impact including the neurobiology of trauma, offenders and sentencing, evidence, jury selection and decision-making, judicial leadership and more. Invites judges to consider how this information relates to their responsibilities in the pre-trial, trial, and sentencing phases of sexual assault trials, and as leaders in the criminal justice system and the community. Suggests ways judges can minimize retraumatization of victims without undermining defendants' rights. Presentations are tailored to the jurisdiction's law and practice.
